Proceedings:

The Quarterly KWIEC meeting was called to order at 1:36 p.m. by Jim Barnhart. Roll was called with the following members responding:

Jim called for any discussion on the last quarter's meeting minutes. With there being none a vote was called and the minutes were approved.

Chairperson's Report (Briefed by Chuck Miller):

- The Governor's Office has not sent out the new/renewal appointments yet
- The 2012 SCIP review is planned for 1st quarter of 2012
- The SCIP revision meeting will be held with the PSWG
- Updates to the SCIP will address UASI, KEWS, Mutual Aid, and Broadband
- Planned review by the KWIEC will be late Q1 to mid Q2
- Publish SCIP update target will be Q2 of 2012
- The 2012 Annual Report on Public Safety Communications Interoperability will report our biggest obstacles as the narrowbanding deadline, noncompliance to P-25
- KWIEC members were asked to send any questions, comments, or information they want to include on the 2012 report to Chuck.
- Wireless projects continue to primarily be funded thru the grants program.
- The 2012 grant cycle is a few months away and it is expected that OEC will hold their ground on guidance in 2012.
- OEC/KWIEC requirements were adhered to for communications projects reviewed in 2011
- Brad continues his efforts (FIWG) of looking at other states programs (Indiana referenced last Q) but it is still felt that Kentucky may need a tax/fee to raise funds to meet this requirement
- Chuck asked KWIEC members to consider any goals they would like to include in the 2012 and future plans. It will be discussed next quarter.

<u>Public Safety Working Group Report (Briefed by Derek Nesselrode):</u>

There has been little change since last quarter and the PSWG will continue to monitor the situations with:

- narrowbanding where is Kentucky; will they extend the deadline
- GPS interference issues with the LightSquared equipment
- The entire broadband / D- Block issue

Kentucky Emergency Warning System update (Briefed by Jeff Mitchell):

- The eastern portion of the new KEWS digital system is up and working
- The Western portion of the new KEWS network is about 1/3rd complete with the first loop in the west having traffic cut to it.
- The remaining two loops in the West will be completed and cutover in the coming weeks
- · Detailed improvements to the project were previously briefed
- Summarizing new and expanded capabilities include fully redundant self-healing MPLS network with OC-3 backbone; DS-2 or better on spur sites
